By entering the **Paramore Handwritten Lyrics Giveaway** (the "**Sweepstakes**") operated on CBSI's @metrolyrics page on the Twitter web site, accessible at the domain "twitter.com " (the "**Twitter Service**"), you hereby accept and agree to these official rules (the "**Official Rules**") of this Sweepstakes, and the decisions of the Administrator in connection with this Sweepstakes, whose decisions are final.

5. Grand Prize: The Sweepstakes will award one (1) Grand Prize (the "**Prize**") that consists of one (1) handwritten lyric sheet by the recording artist Paramore provided through their record label Fly South Music Group. There is no retail value for the Prize.
